**Learning Community:
Linking People, Place and Perspective**

Course Description

Participants develop and share a view of their own community, which includes current issues, concerns, opportunities and leadership and ultimately develop an issue management process.

Overall Course Objectives

- ◇ Develop strategies to recognize informal versus formal systems, themes versus issues and the components of productive harmony.
- ◇ Use information gathered through community observation to identify community places, people and behaviors.
- ◇ Identify the informal and formal networks in their community and explore strategies to assess and use networks in their management systems.
- ◇ Identify “7 Cultural Descriptions” as gathered from field experience.
- ◇ Develop an process which integrates community issues and agency concerns.

- ◇ Describe what “cooperating agency status” means and how to apply it in planning and NEPA.
- ◇ Set the stage for a collaborative community approach to planning.
