BLM's New Modules Training for AFMSS 2 Users Deployment Schedule 2021

The Bureau of Land Management (BLM) is inviting you to attend a one-day, virtual training for two new modules, Portal and WISx, in the Automatic Fluid Minerals Support System (AFMSS 2). Please note updated dates for WIS Shutoff are displayed in **Red**.

Field Offices Transition Dates

All users will transition to AFMSS 2 for Sundry Notices and Well Completions as follows:

- Worland – October 19, 2020
- Miles City – November 2, 2020
- Vernal – December 7, 2020
- Carlsbad and Hobbs – January 11, 2021
- Farmington, Rio Puerco, and Roswell – January 25, 2021
- Colorado – all field offices – February 22, 2021
- Wyoming – all field offices – April 5, 2021
- Montana/North Dakota/Oklahoma/ Eastern States – May 17, 2021
- Utah/California/Alaska/Nevada – June 14, 2021

Training sessions are focused for those who currently submit Sundry Notices and Well Completion Reports utilizing the Well Information System (WIS) and will provide virtual training and the opportunity for questions about the new modules in AFMSS 2. By the end of this training, users will be able to successfully submit Sundry Notices and Well completion Reports using WISx as well as navigate AFMSS 2 through the new Portal.

WIS Dates for Disabling Field offices

Also, please note that the WIS program will be unavailable effective the date below for the field offices to allow for data migration. During this time, please submit any Sundry Notices and Well Completion Reports via paper. WIS shut off dates:

- Worland – October 2, 2020
- Miles City – October 16, 2020
- Vernal – October 30, 2020
- Carlsbad and Hobbs – December 28, 2020
- Farmington, Rio Puerco, and Roswell – January 11, 2021
- Colorado – February 8, 2021
- Wyoming – **March 15, 2021**
- Montana/North Dakota/Oklahoma/ Eastern States – **April 26, 2021**

- Utah/California/Alaska/Nevada – May 24, 2021

Operator Training Sessions

There is a choice for AFMSS 2 new modules training during each week of Field Office training. Listed below are the available dates for training:

- Miles City – November 4 or November 5, 2020
- Vernal – December 9 or December 10, 2020
- Carlsbad and Hobbs – January 13, 2021 or January 14, 2021
- Farmington, Rio Puerco, and Roswell – January 27, 2021 or January 28, 2021
- Colorado – February 24 or February 25, 2021; March 3 or March 4, 2021
- Wyoming – April 7 or April 8, 2021; April 14 or April 15, 2021
- Montana/North Dakota/Oklahoma/ Eastern States – May 19 or May 20, 2021; May 26 or May 27, 2021
- Utah/California/Alaska/Nevada – June 16 or June 17, 2021; June 23 or June 24, 2021
